**Ascension Place provides sober supportive housing for up to 32 women. Residents have private bedrooms, shared bathrooms, and 24-hour staff support as well as daily meals, snacks, personal care items, clothing, internet service, laundry facilities, and an onsite library, garden, and reflection room. Case Managers provide individual and group support to women to help them stabilize and heal after experiences of homelessness, incarceration, substance abuse, or mental health concerns, and set and work toward their future goals. Supportive programming includes weekly chemical and mental health groups, financial literacy support, health, wellness, and arts activities and workshops, opportunities for sober fun, and community-building activities.**
